**REGULATION ORDINANCE NO. 2023-192**

**AN ORDINANCE AMENDING REGULATION ORDINANCE NUMBER 2023-175, ENTITLED, "AN ORDINANCE FOR THE CREATION OF THE TRAFFIC ADJUDICATION BOARD (TAB) PROVIDING FOR ITS FUNCTIONS, DUTIES AND RESPONSIBILITIES THEREOF AND FOR OTHER PURPOSES" BY REMOVING SECTION 3 BURDEN OF PROOF THEREOF**

*Sponsored by Councilor Romel D. Duron, and seconded by Coun. Jose Maria Miguel S. Treñas, Coun. Candice Magdalane A. Tupas, and Coun. Leila G. Luntao*

**WHEREAS**, the Sangguniang Panlungsod passed and approved Regulation Ordinance No. 2023-175 entitled, "An ordinance for the creation of the Traffic Adjudication Board (TAB) providing for its functions, duties and responsibilities thereof and for other purposes";

**WHEREAS**, Section 3 of Regulation Ordinance No. 2023-175 states that, to wit:

*“Section 3. **BURDEN OF PROOF.** – Any driver of motor vehicle apprehended by any traffic enforcement personnel of the Iloilo City Government or its deputized agents may contest the traffic apprehension before the Traffic Adjudication Board of the City of Iloilo.*

*The apprehending traffic enforcement personnel has the burden of proof and shall prove before the Traffic Adjudication Board that the driver was properly apprehended”.*

**NOW, THEREFORE**, be it ordained as it is hereby ordained by the Sangguniang Panlungsod, in session assembled that:

**SECTION 1.** Section 3 of Regulation Ordinance Number 2013-175- Burden of Proof, is hereby deleted.


**SECTION 2. REPEALING CLAUSE** – All ordinances contrary to or inconsistent with this Ordinance are hereby repealed or modified accordingly.

**SECTION 3. SEPARABILITY CLAUSE** – If any part or provision of this Ordinance is declared unconstitutional or invalid, the same shall not affect the validity and effectivity of the other parts or provisions hereof.


**SECTION 4. EFFECTIVITY CLAUSE** – This Ordinance shall take effect upon approval.
