RESOLUTION NO. 2020-577

A RESOLUTION REQUESTING THE LTO/LTRFB TO REFRAIN FROM ENFORCING THE WEARING OF FACE MASK/FACE SHIELD BY DRIVERS AND PASSENGERS AND IN LIEU THEREOF ALLOW THE CITY GOVERNMENT THRU THE PSTMO, BARANGAY OFFICIALS TO ENFORCE, PURSUANT TO ILOILO CITY ORDINANCES WHICH ALSO PENALIZED THE NON-WEARING OF FACE MASK/ FACE SHIELD

WHEREAS, Article II, Section 15 of the 1987 Philippine Constitution declared that it is the policy of the state to protect and promote the right to health of the people;

WHEREAS, The President declared a State of Calamity throughout the Philippines due to the Corona Virus Disease 2019 (COVID 19);

WHEREAS, Republic Act 11469 was enacted declaring a national health emergency throughout the Philippines in view of the serious health threats and disruption posed by COVID-19 on the lives and livelihood of the people and economy;

WHEREAS, pursuant to the safety measures set forth by the IATF, the DOTr, LTFRB and the LTO issued the protocol/guidelines for Land Transportation Operations, which guidelines is in relation to Section 3 Paragraph 13 of the IATF authorizing said agencies to issue guidelines pertinent to the operation of land transportation, particularly the wearing of face mask/face shield by Drivers and passengers;

WHEREAS, the City has an ordinance regarding the wearing of face mask and is about to pass an ordinance about the wearing of face shield in the entire City of Iloilo;

WHEREAS, the wearing of face masks/face shield is definitely considered a violation of **health protocol**, and not a traffic violation, and the City Government of Iloilo is believed to be in the best position to implement the same when it comes to health protocol, such as movement restrictions of persons;


NOW THEREFORE, on motion of Hon. Romel D. Duron, Co-sponsored by Hon. Jose Efrain G. Treñas, III, seconded by Hon. Lyndon V. Acap and Hon. Mandrie T. Malabor;

RESOLVED, as it is hereby resolved, by the Sangguniang Panlungsod of the City of Iloilo, that a resolution be passed **REQUESTING THE LTO/LTFRB TO REFRAIN FROM ENFORCING THE WEARING OF FACE MASK/FACE SHIELD BY DRIVERS AND PASSENGERS AND IN LIEU THEREOF ALLOW THE CITY GOVERNMENT THRU THE PSTMO, BARANGAY OFFICIALS TO ENFORCE, PURSUANT TO ILOILO CITY ORDINANCES WHICH ALSO PENALIZED THE NON-WEARING OF FACE MASK/ FACE SHIELD**

RESOLVED, FURTHER, that copies of this resolution be forwarded to the City Mayor's Office, Land Transportation Office, DOTr, and LTFRB, for their information and guidance.
